- Member successfully attended all relevant STCW revalidation courses and received their revalidated Certificate of Competency (COC) in year 2020 or 2021.
- Membership must be fully paid-up at the time of application.
- Members must have at least 6-months continuous membership with the Union.
- Singaporean / Singapore Permanent Resident.
- Actively sailing SMOU member (provide a copy of your latest discharge book).
- Provide all relevant certificates and revalidated certificates of competency upon application.

Achievement Incentive

Eligibility

- Membership must be fully paid-up at the time of application.
- Members must have at least 6-months continuous membership with the Union.
- Singaporean / Singapore Permanent Resident.
- Actively sailing SMOU members (provide a copy of your latest discharge book).
- Must complete shipboard training or upgrading training.
- Member to provide an upgraded higher Certificate of Competency (COC) or cadet who has obtained First Certificate of Competency (COC) / issued in year 2021 upon application

- a) All applications for SMOU Revalidation & Achievement Awards must be made on the prescribed form fully completed and received by SMOU before the official **closing date: 31 December 2021**. Applications received after the closing date will not be accepted.
- b) Each member can only apply for ONE SMOU 70th Anniversary Training Incentive.

 - Original copies of COC
 - Original copies of Seamen book / Discharge book / Letter of Employment

- e) Furnish other documents or information as may be reasonably requested by SMOU from time to time for the purpose of SMOU's audit of the Applicant's reimbursement claims.
